5. Operations

5.1. CEO Report

The recent fire damage as a result of a fire in the gym was limited to smoke damage only. The stadium was closed to air out the building and an insurance clean undertaken. The interior roof and fan cleaning is required and access requirements are being worked through. It is hoped the main building entrance will open in the next two weeks.

CEO attended Bayside City Council Sporting Groups meeting with the mayor on Sunday 14th March. Council met on Tuesday 16th and the 4 new courts was back on the Council agenda. The stadium design has been modified to address environmental concerns regarding impacts to the flora, fauna and burrowing species of frogs in the area. The design has also been changed to address Council's climate emergency agenda with solar panels and automatic louvres added to the design. To offset increased project costs a number of other changes were made to the design. Council voted to pass the motion to change the design and make up the funding shortfall. In addition to the \$1m upfront payment, it was agreed to increase the SBA contribution from \$1.5m to \$2m over a 20-year leaseback contribution.

The 4 change rooms at court 1 are going to be updated (painting and other cosmetic changes) and will be made available to VJBL Sabres home teams pre and post game.

It was proposed that James McKinnon's hours be increased from part-time to full-time. James will continue to be responsible for sales, marketing and communications, but will also take on the role of Assistant Head Coach Boys.

Decision: The Board unanimously approved the increased hours for James McKinnon.

NBL1 players are currently being signed and player announcements have commenced. Season starts 21 April.

5.2. Court Funding Planning

Possible funding options will be discussed and socialised with Domestic Club Presidents. A meeting will be scheduled with Presidents after April school holidays.

5.3. Risk Management during Covid

Continuing to follow government and Basketball Australia guidelines. Continuing to sanitise and maintain entrance at court 1.
