#### 5.1. CEO Report

Spring season has been delayed due to 6.0 lockdown extension (to 2 September). This will have a substantial impact on income. Grants and disaster payments are being explored. A staff timetable for next 3 weeks including annual leave and days in lieu is being developed to address the lockdown.

The second stage of bench seating has been installed on courts  $1\ \&\ 2$ .

SAMS (Sabres Athlete Management System) Referees review draft phase has commenced.

Basketball Victoria has confirmed the SBA has been granted a NBL1 license for 2022. Review of the senior Sabres program is underway incorporating coaches and players for NBL1, VY, U21 and U18 for 2022.

With the disruption to the VJBL season, a 25% credit is being explored to be applied to the 2022 season (depending on whether there is a return to games).

Communications / Marketing Officer role was discussed and a general profile and background.

Coaching clinics are continuing being run during lockdown and a training /rep ready online program is being explored.

#### 6. Finance & Audit

No invoicing occurred to Domestic Clubs for the domestic spring season and this is on hold until lockdown lifts.
